Brandon Coleman reported that he talked to Mary Margaret Winton and ask her if there was any kind of agreement and she said no and she wanted to know if Brandon could put together some kind of agreement so Brandon got on together and sent out to other Supervisors to review and decide what we want to do and we were having this work session and thought you could give us update what is going on with Chestnut Grove as a lot of people are asking questions.

Jim Russo reported we had to get permits and after 4 1/2 years we had Army Corp, Historical Society wanted to do another dig. Then 2020 COVID hit the gov. went out. DCNR gave us a \$300,000.00 grant so we had to redesign the entire park and new specs on it. McTish was doing that for us but they were bought out. We got everything underground and is complete except for Electrical. The landfill did about half million dollars groundwork, storm sewers are in place, sanitary, storm pause and catch basins are in place. Rick Bowman has contract for civil work and Turnkey Electrical has contract for the electric for 3 fields at the East Park includes fencing, back stops, grading ADA area and pavilion area. We were over \$400,000.00 over the budget and the contractor came to us. Mary Margaret Winton said that the low bidder bail out so we had to request from DCNR a change order which that took time to get it back and we got the approval about three weeks ago. The county was great they gave us some \$80,000. In for the engineering and Steve Gibson is still on board. Within the next month you will see activity with Turnkey and Bowman on sight. Our intension is baseball in the spring of next year and we have a gentleman in Howard who runs International baseball tournaments all over East coast part of the board and we are getting him on board to market our fields. The only intentions is for tournaments to come into the area so if the City of Lock Haven is letting us use their fields and Flemington and Beech Creek and everyone gets paid. Castanea has been a big part of this and so what do you want from us, we need to Maintain the fields and we would rather pay Castanea Township then pay John doe lawn service to come in and mow the grass If you have a maintaine crew document the hours and we will pay you. We will have portable food services and we will put in porta potties until we can generate enough money to build the restrooms. Received some donations and will give a list when we get up and operational The project on this East side will be around \$600,000.00. We already have purchases dugouts, benches. Within three weeks you will see Turnkey and Bowman down there working. Brandon Coleman gave Jim a copy of Agreement and explained what the agreement was about and Jim said he will get it sent to everyone and see if the agreement is ok and get it back to us. Jim replied that we said we would rather pay Castanea Township maintenance guys or we will have to get a mowing service to come in and do it. Jim said that sometimes the league guys will come in and mow. Brandon said that would be ok. Discussed the agreement and removed some items and will rewrite the agreement and sign and call Jim and have him pickup agreement and review.

Brandon Coleman made motion with Chestnut Grove to make corrections as noted to agreement to remove volunteers and make it Castanea Township Employees and Township will be reimburse for doing mowing of the East End fields and approve it upon contention of the corrections.

Question was asked if the Township will have the time and the man power to do the mowing. Noticed the Bald Eagle trail has not been getting attention and wanted to know will township have the time.

Terry Neff Sr said that we are in the progress of hiring a full time employee.

Brandon said that if someone wants the job just to mow the Ballfields we can find someone.
